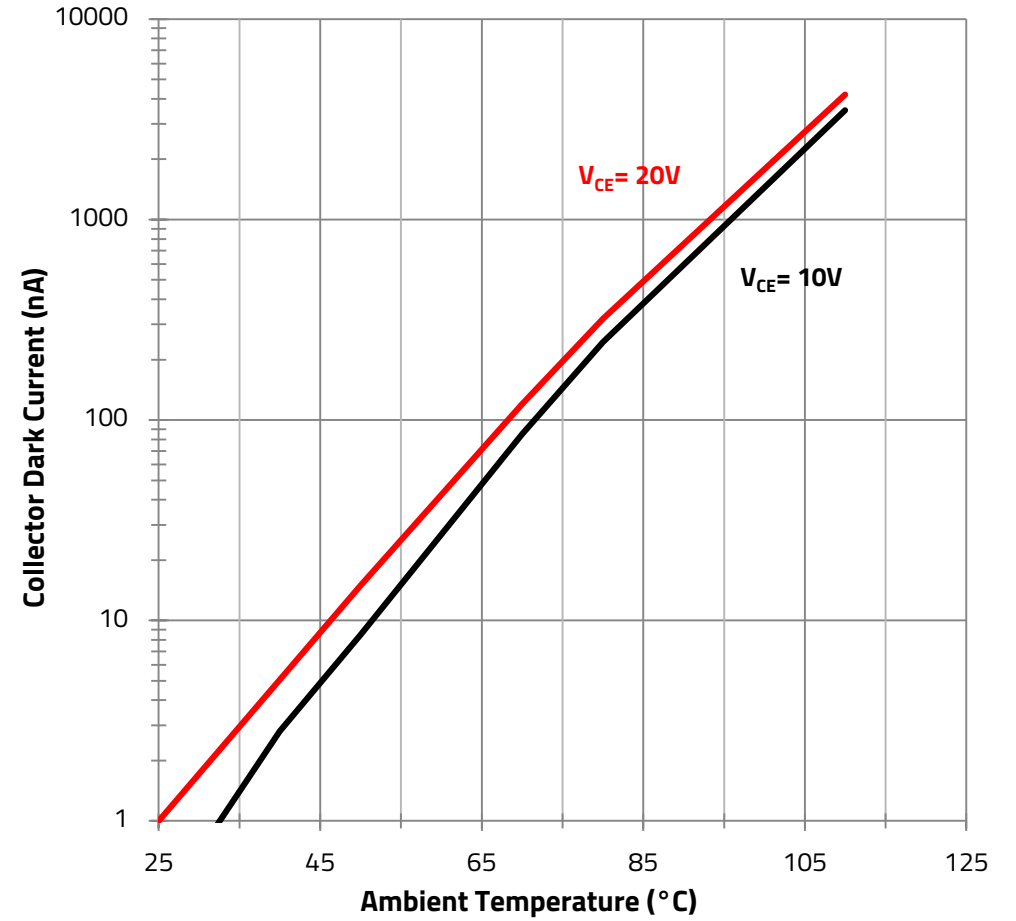

### Collector Dark Current vs. Ambient Temperature:

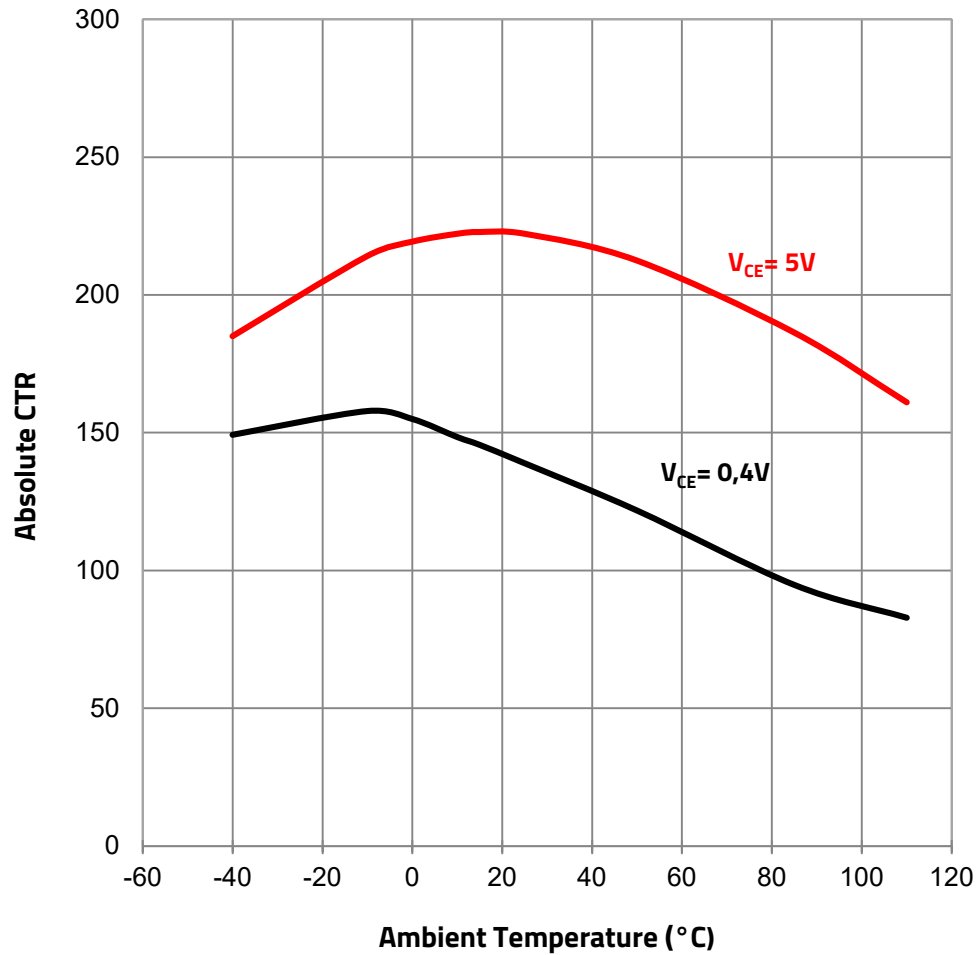

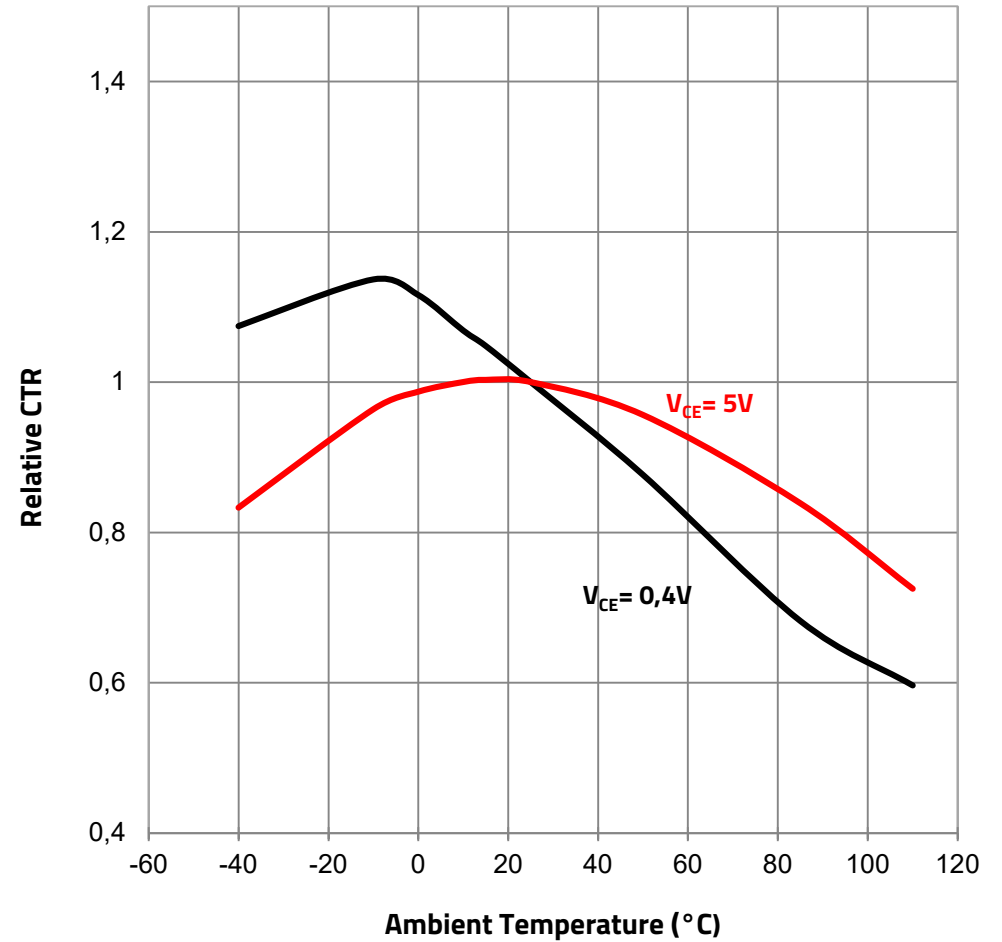

Testcondition: I<sub>F</sub>=5mA, T<sub>A</sub>=25°C, Bin B

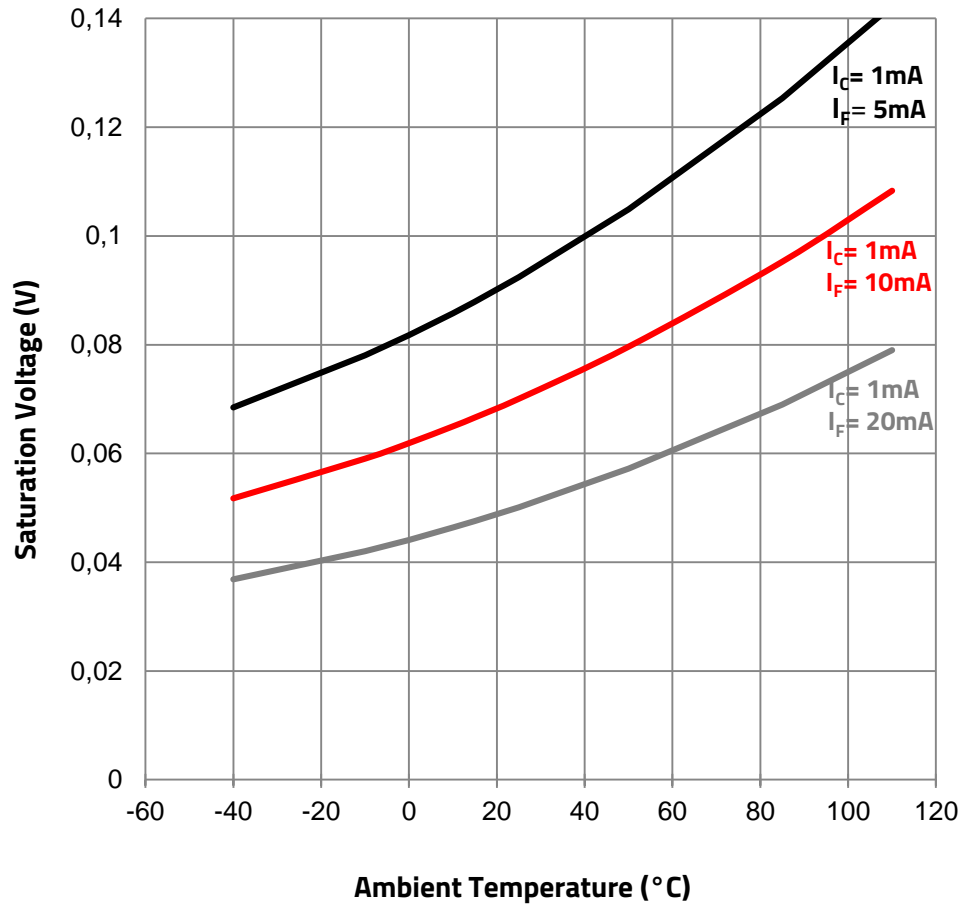
## Relative CTR vs. Ambient Temperature:



Testcondition: I<sub>F</sub>=5mA, Normalized to T<sub>A</sub>=25°C, Bin B

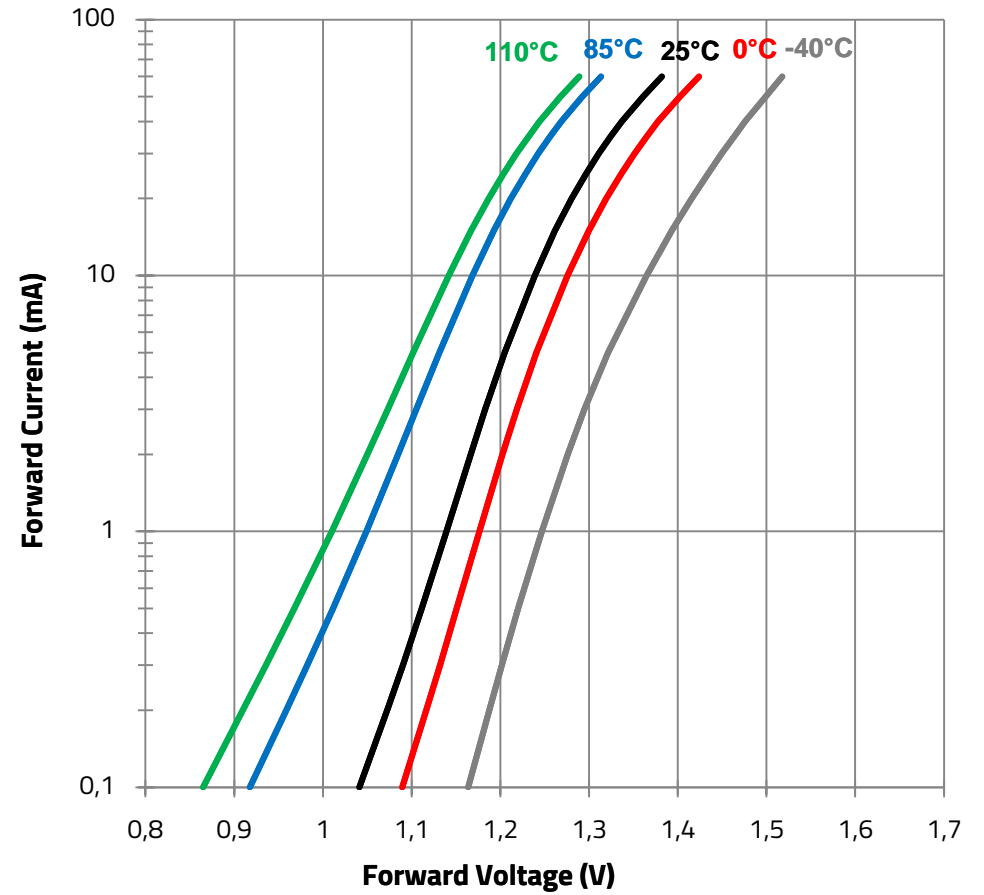

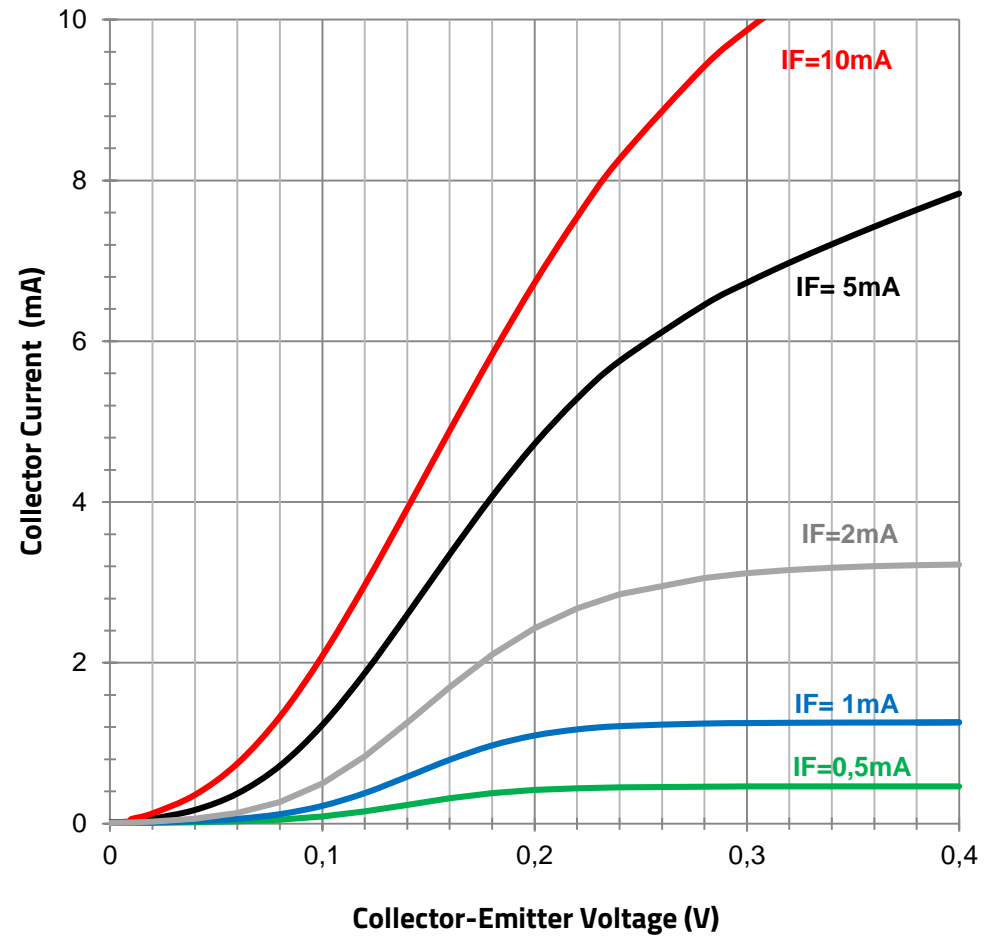

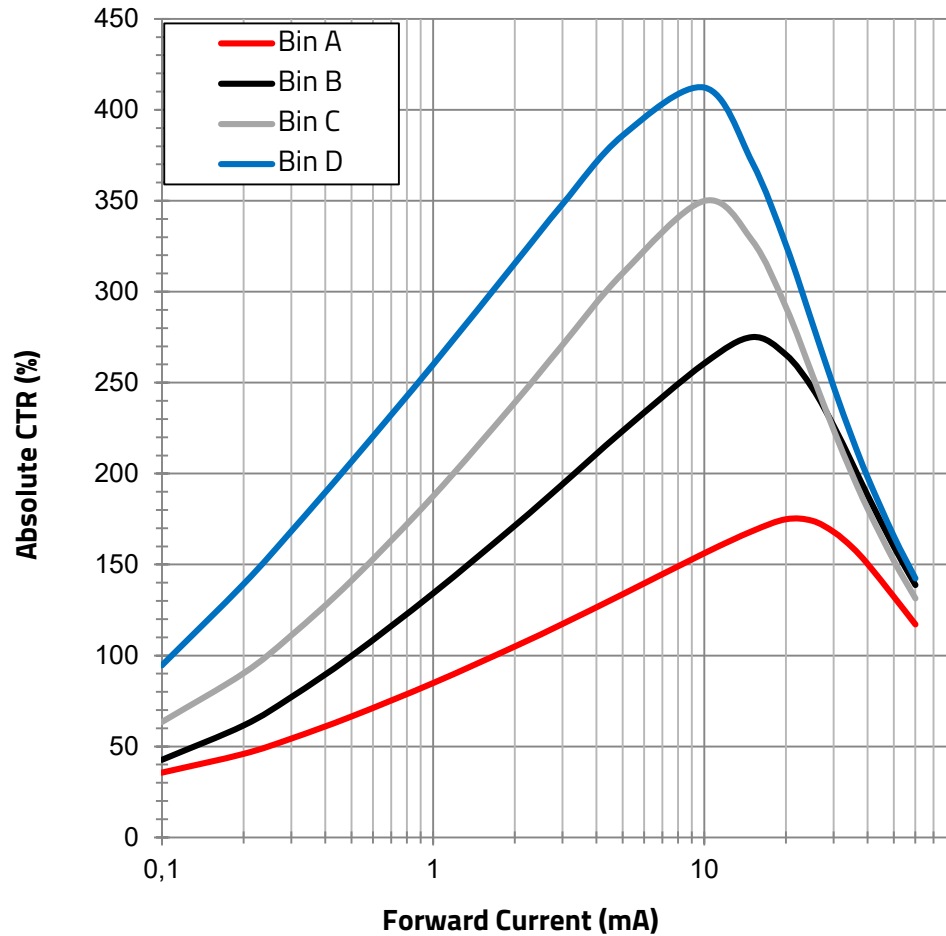
### Collector Current vs. Collector-Emitter Voltage, saturated

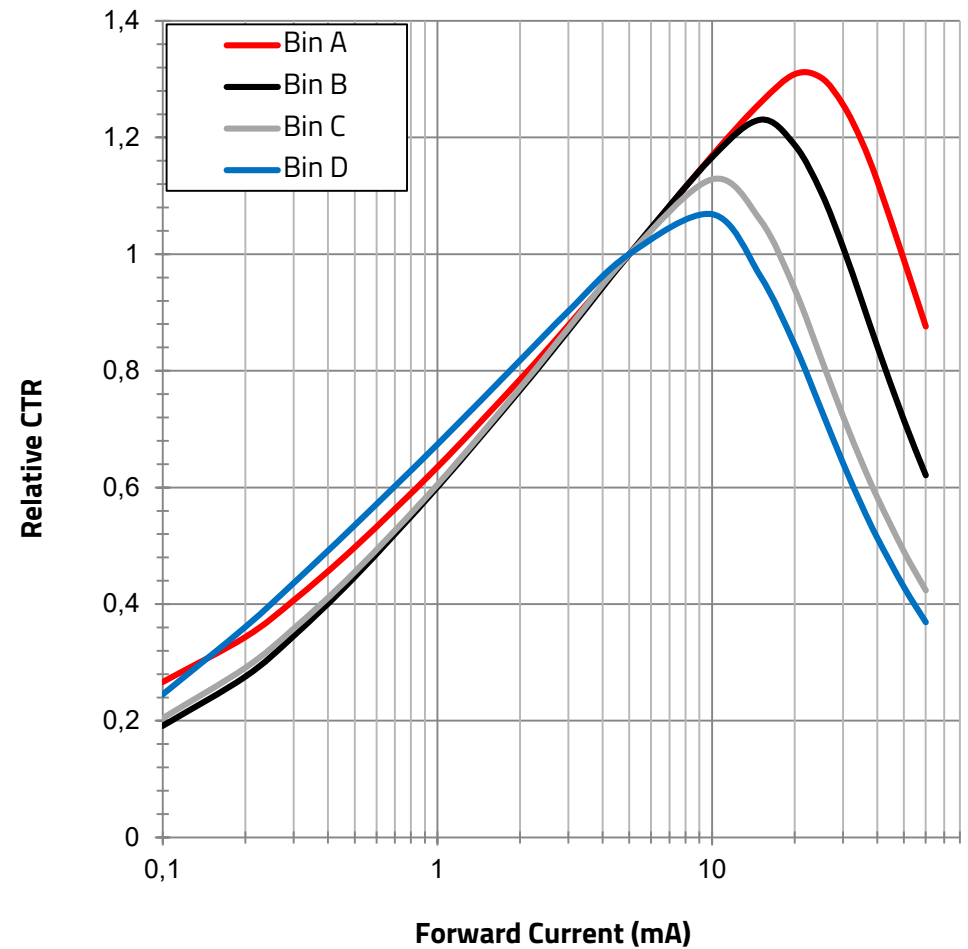

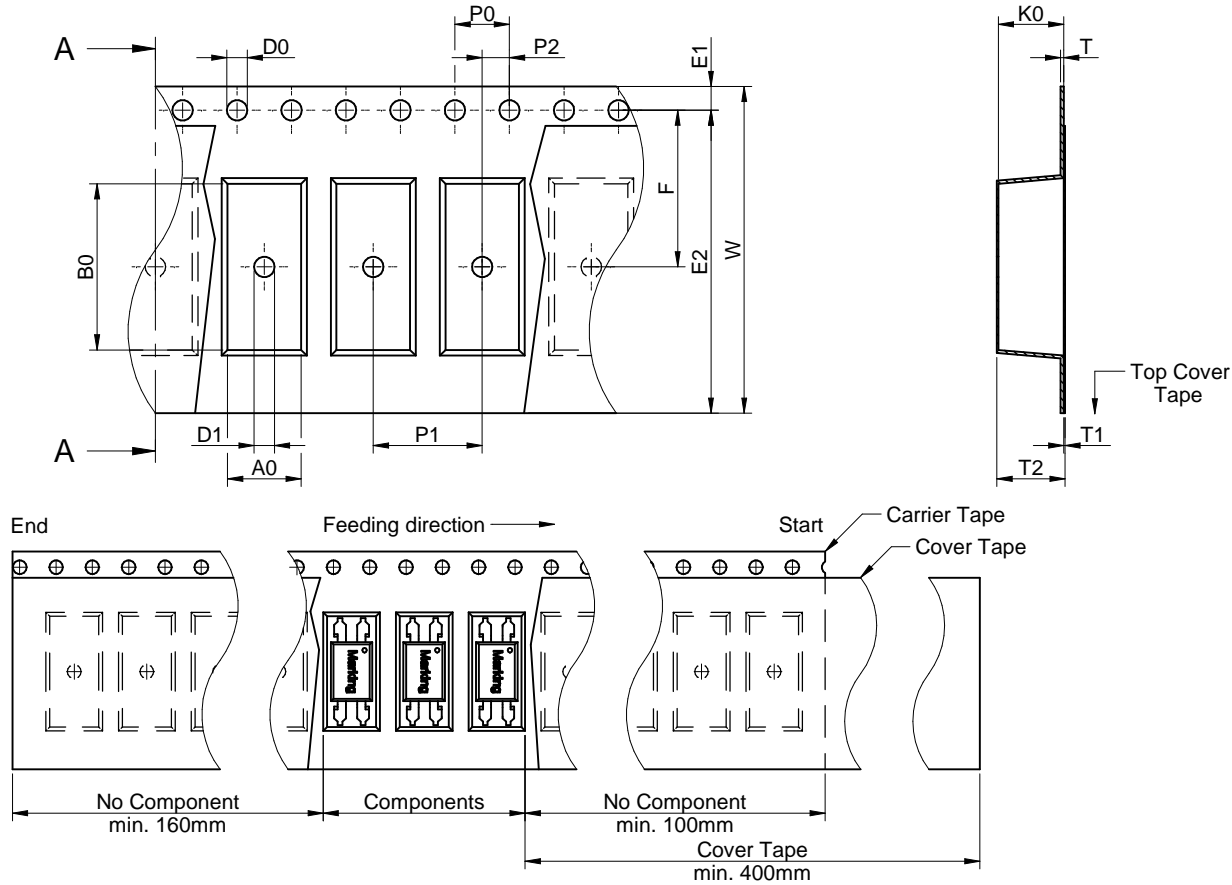
## Frequency Response

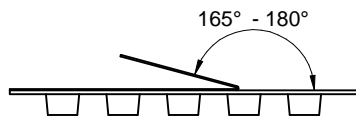

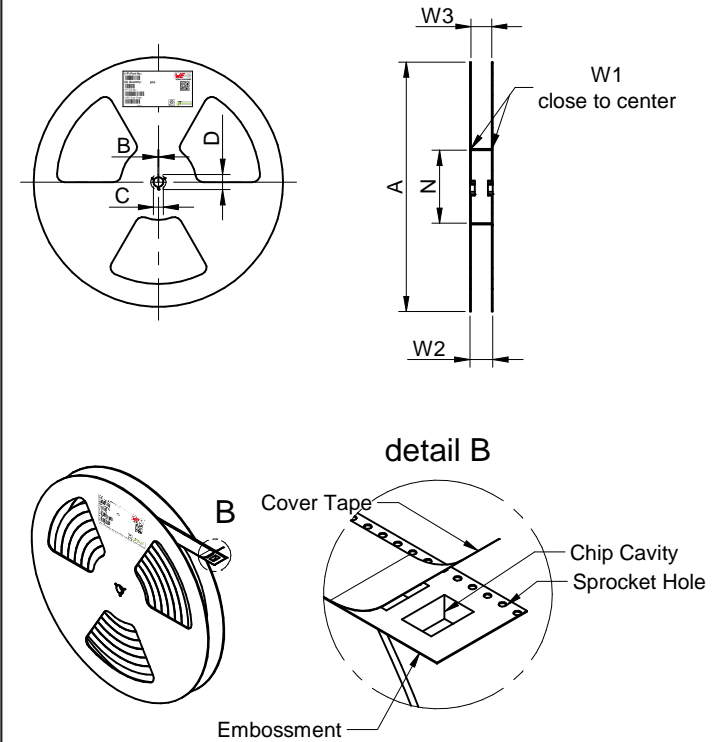

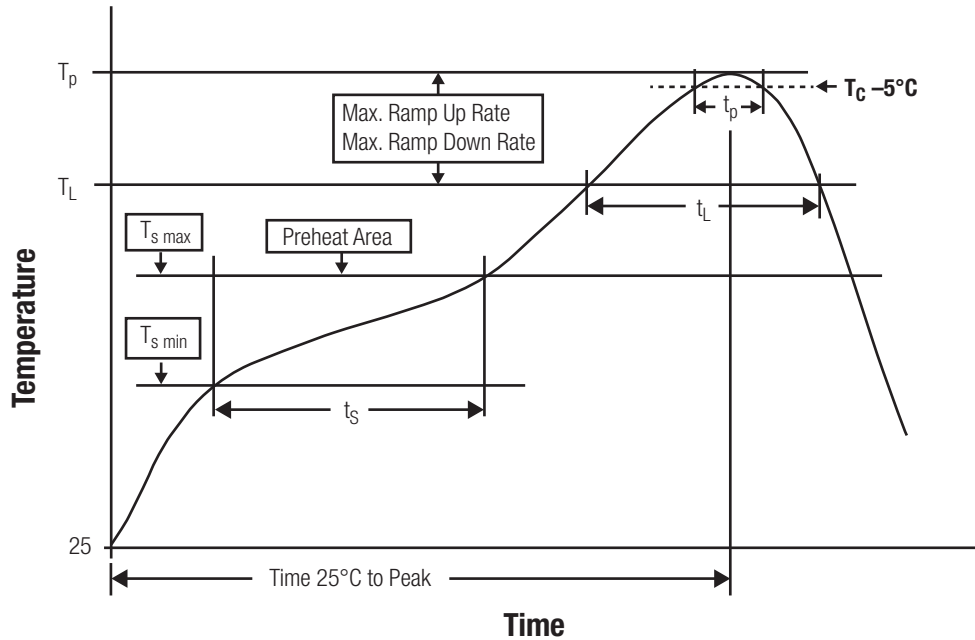

#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.




