### Typical Inductance vs. Current Characteristics:

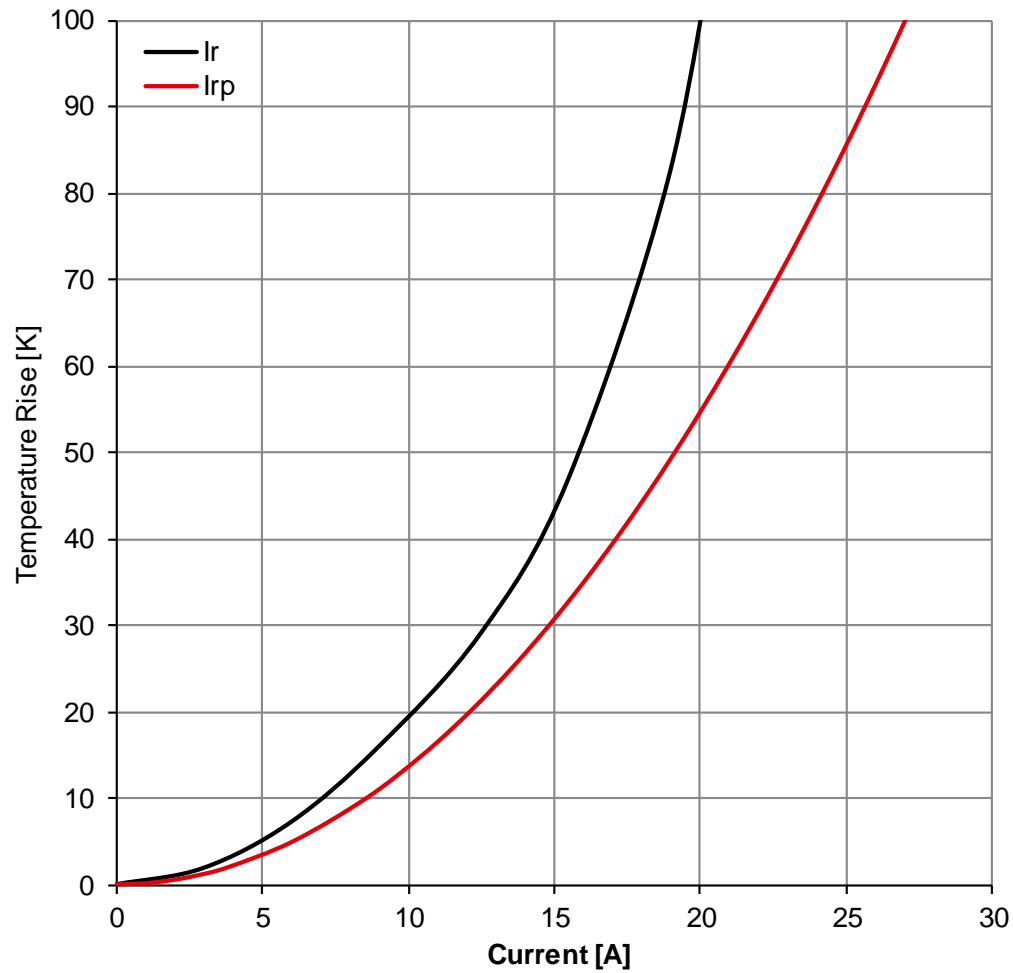








## Typical Temperature Rise vs. Current Characteristics:



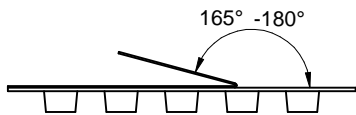
