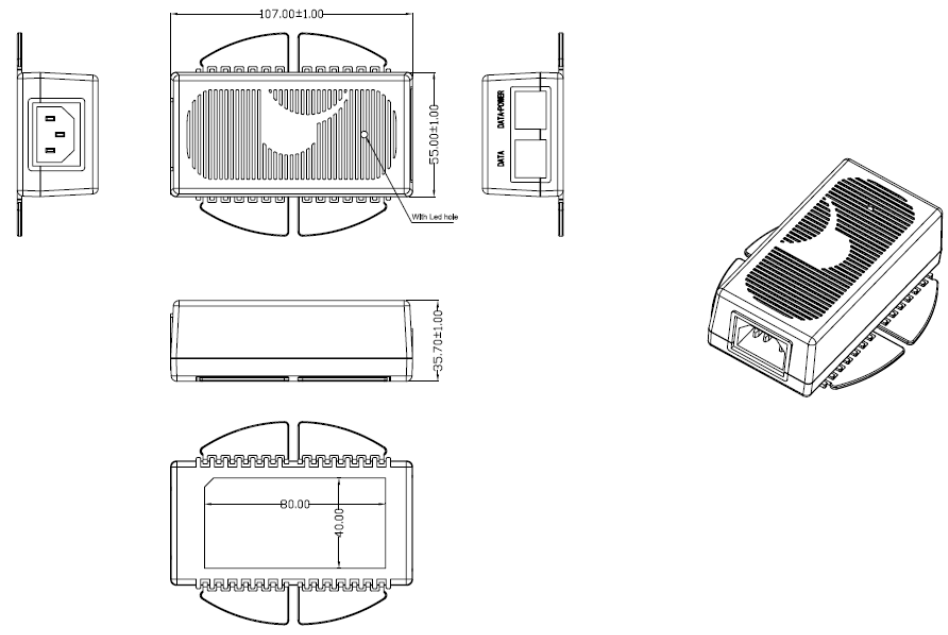

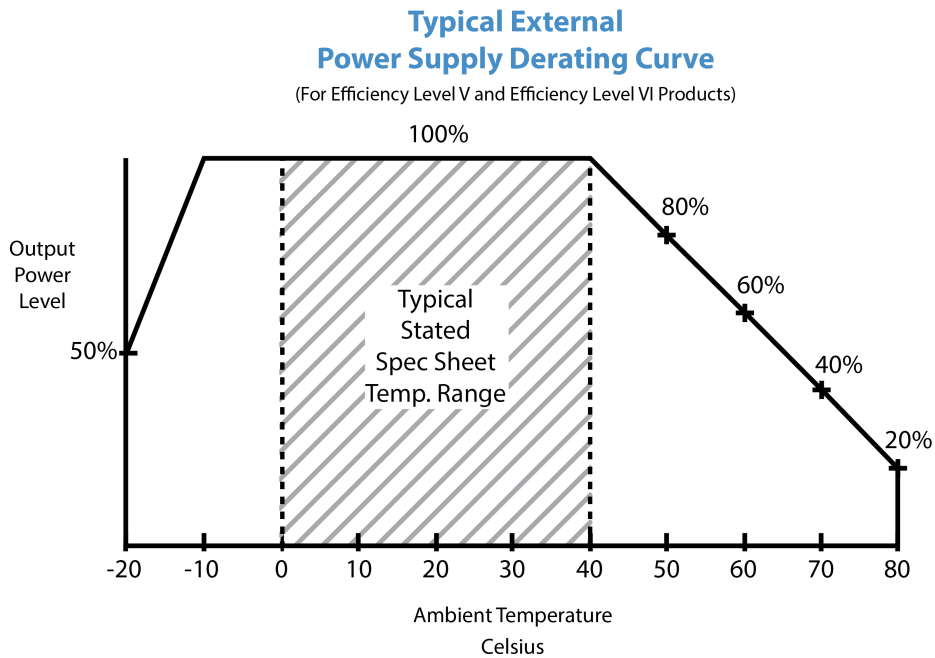

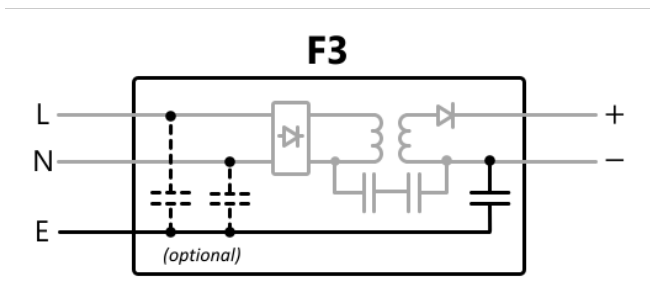
DERATING CURVE
