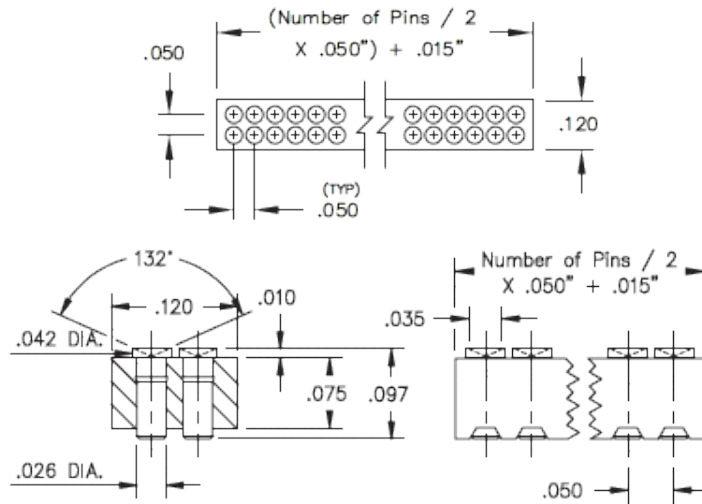

After machining, brass parts are often annealed (softened) for subsequent bending, swaging or crimping. A partial anneal down to  $60 \pm 10$  RB is recommended for  $90^{\circ}$  bends, a full anneal down to  $35 \pm 15$  RB is recommended for pins or terminals

that are swaged (riveted) to a circuit board or crimped to a wire.
