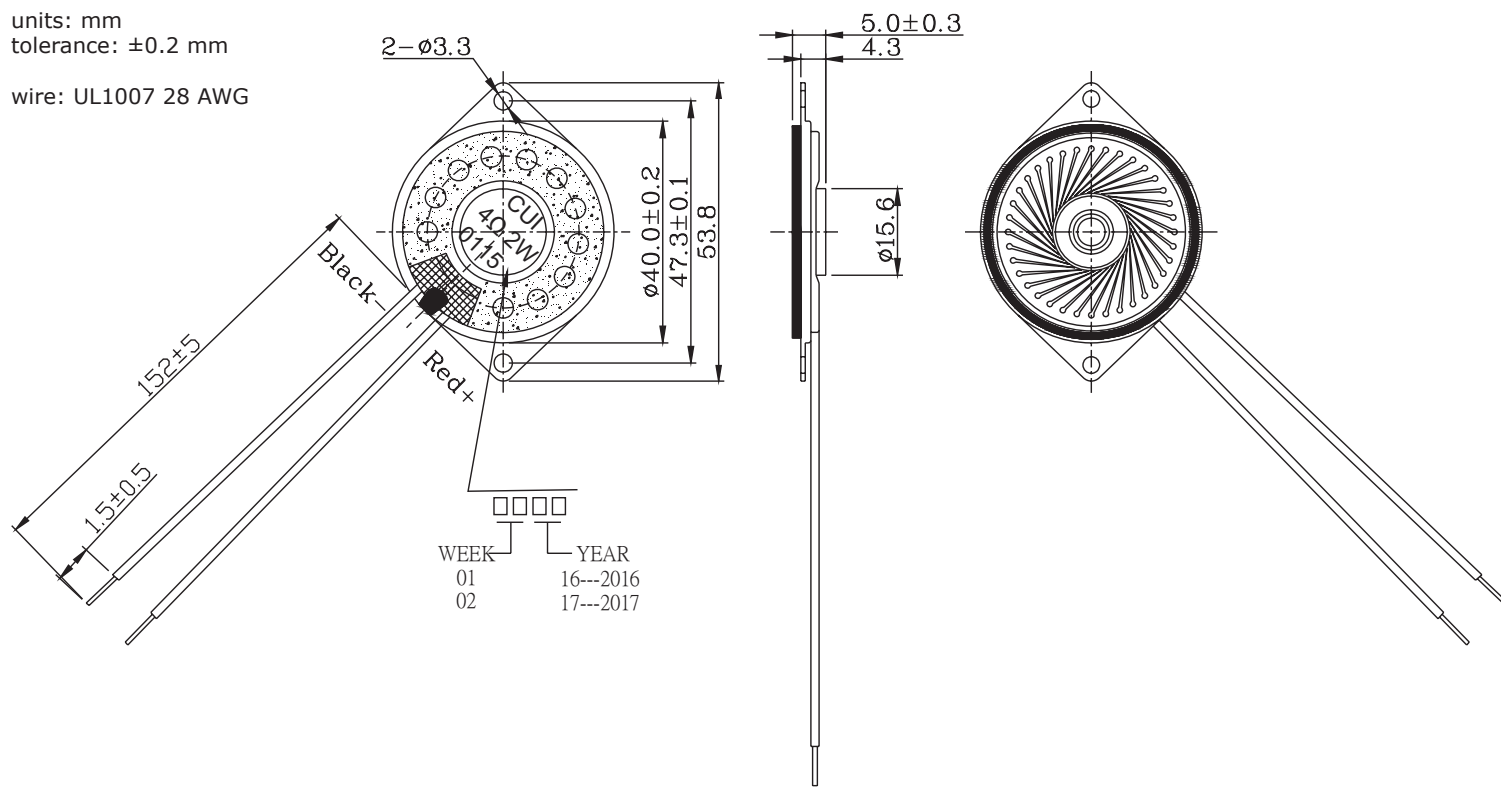

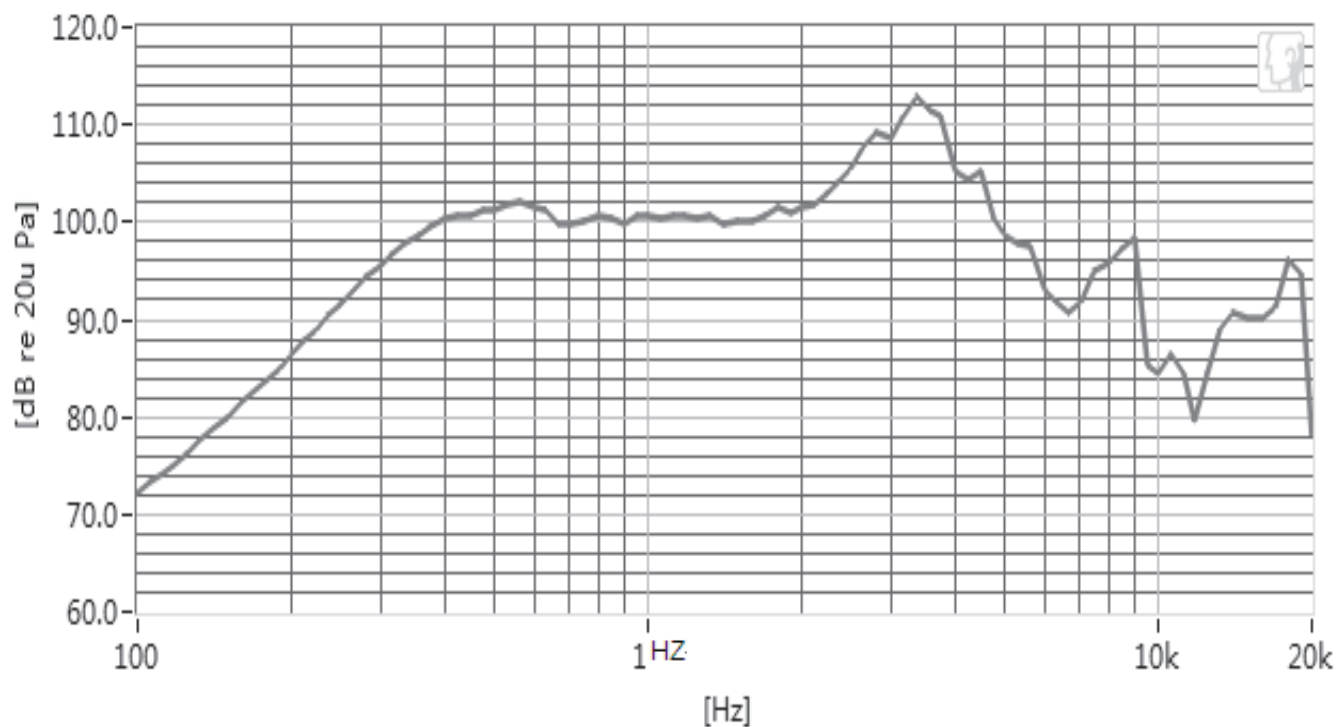

FREQUENCY RESPONSE CURVE

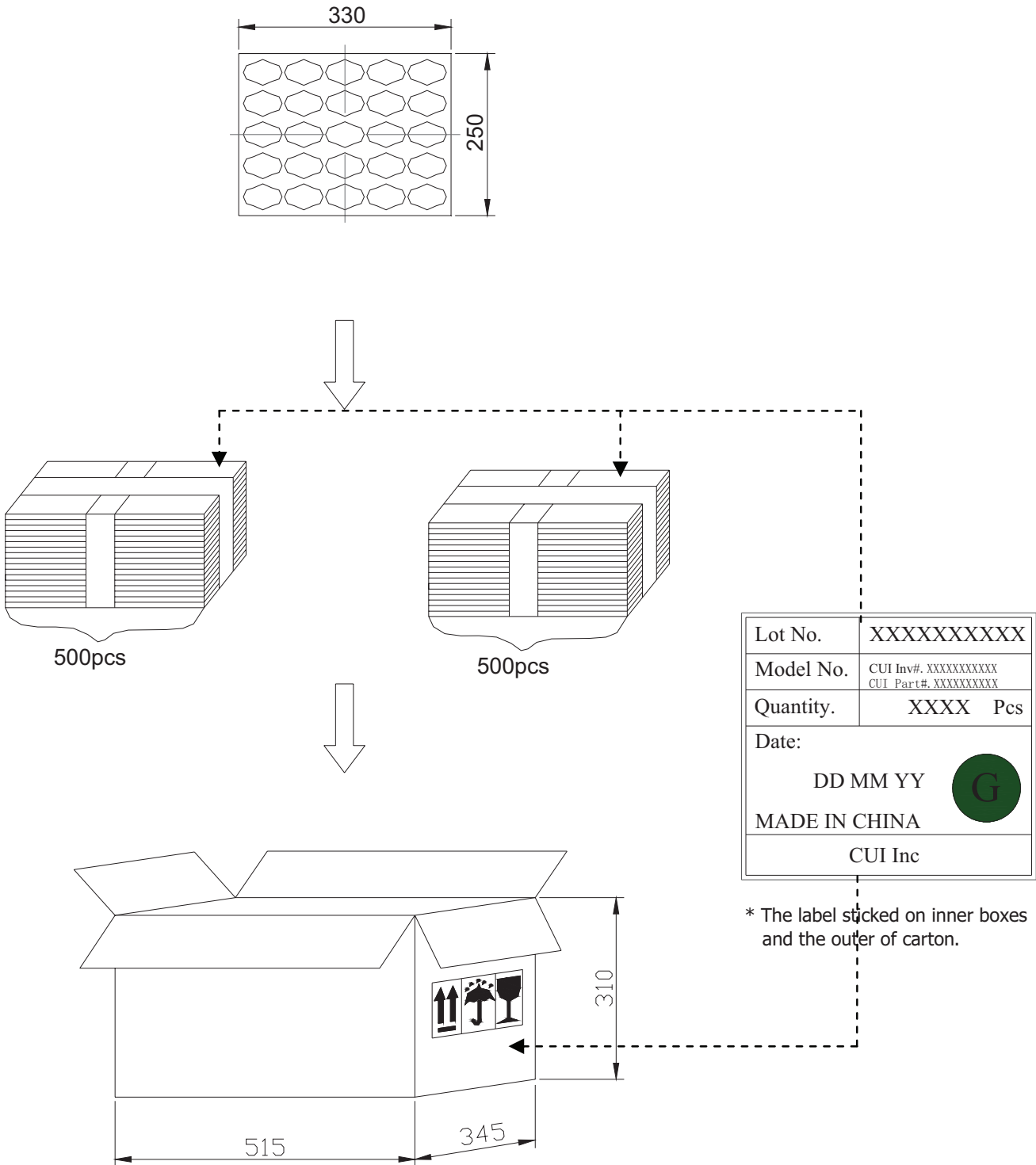
Frequency Response.Magn dB re 20.00 μ PA AT 1 W / 0.1 m
