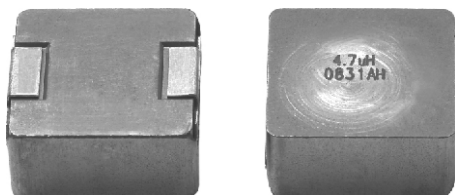

Notes

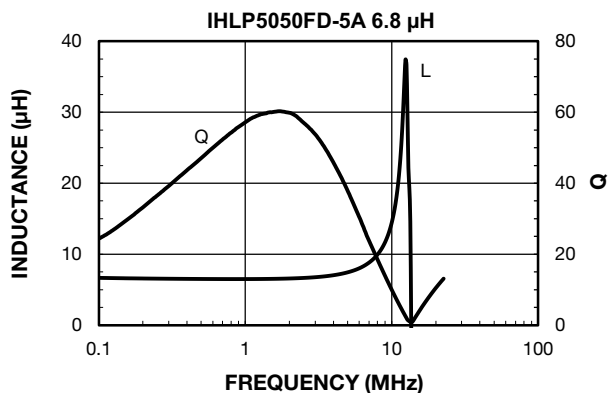
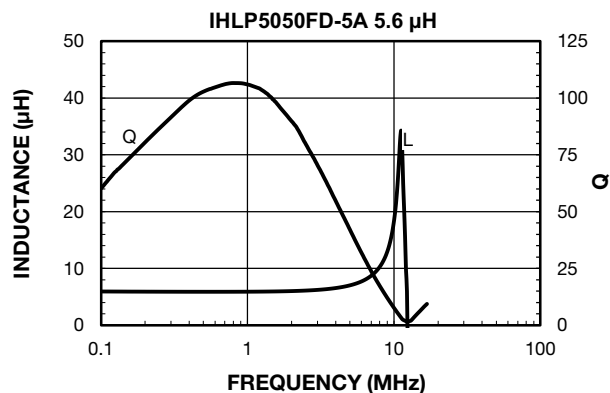
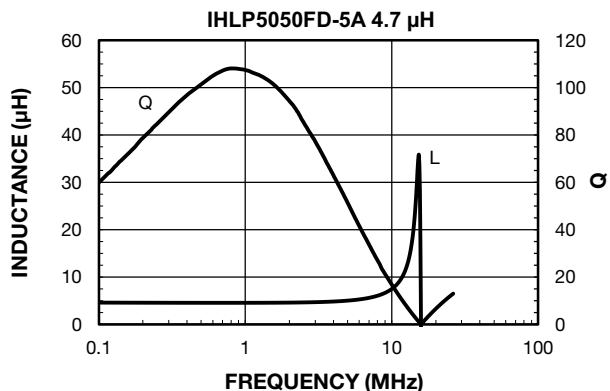
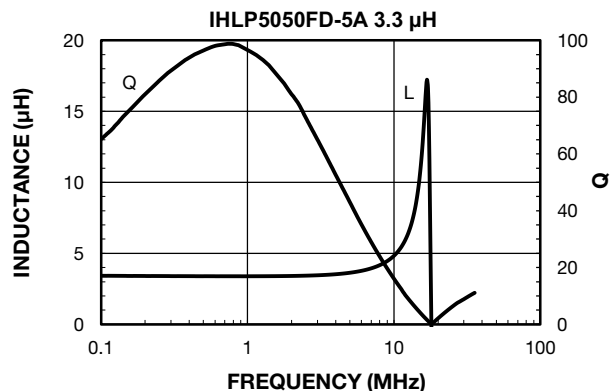
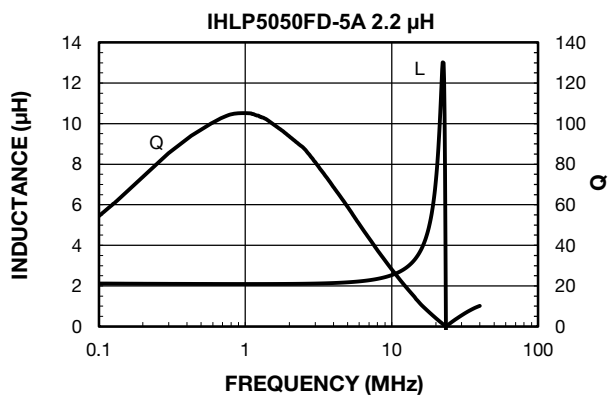
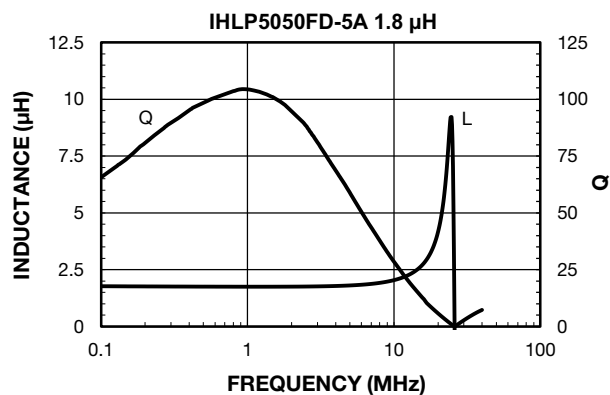


PERFORMANCE GRAPHS: INDUCTANCE AND Q VS. FREQUENCY



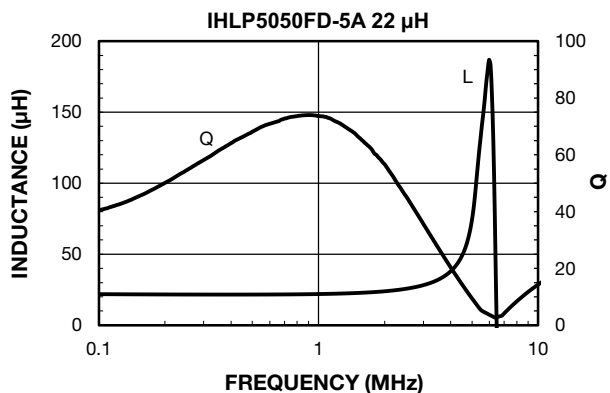
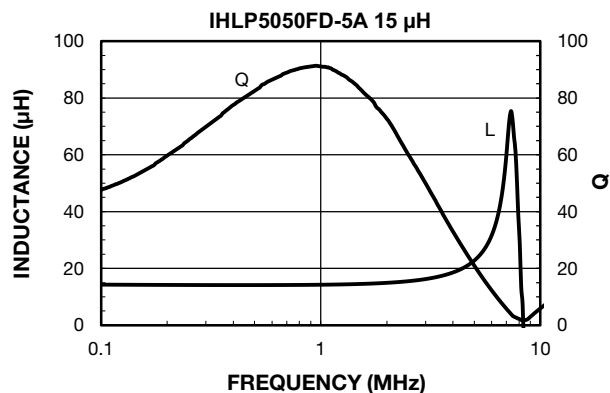
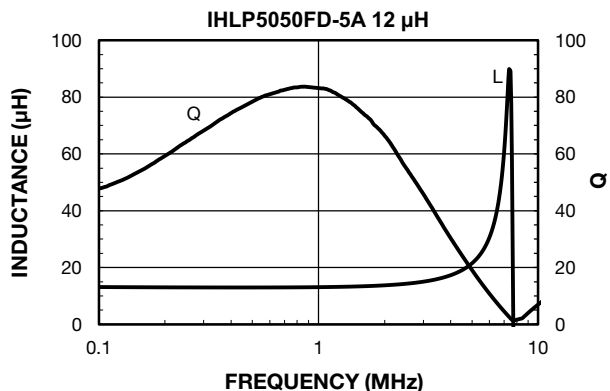
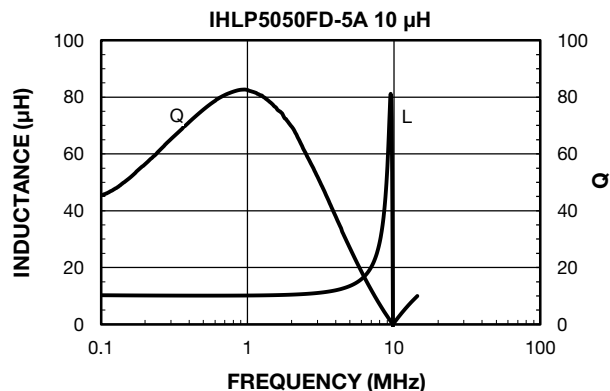
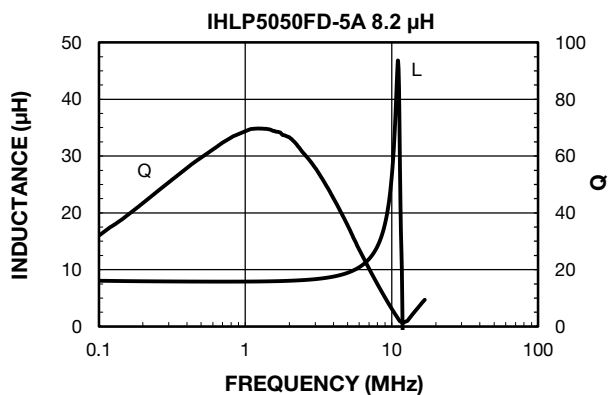
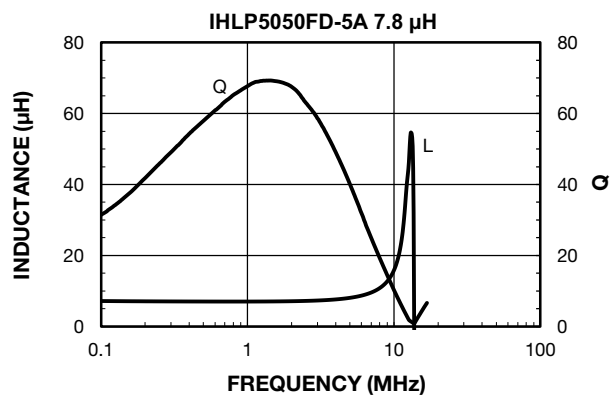


PERFORMANCE GRAPHS: INDUCTANCE AND Q VS. FREQUENCY
