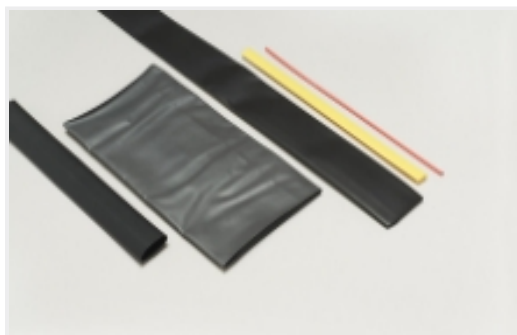

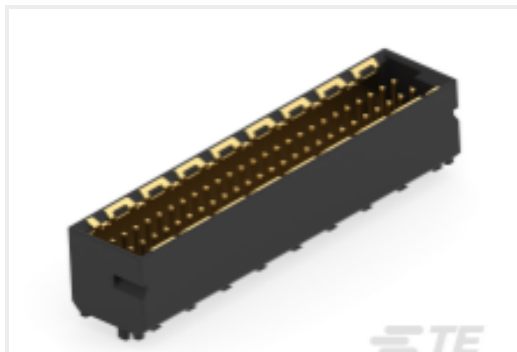


Orange Heat Shrink Tubing(11)

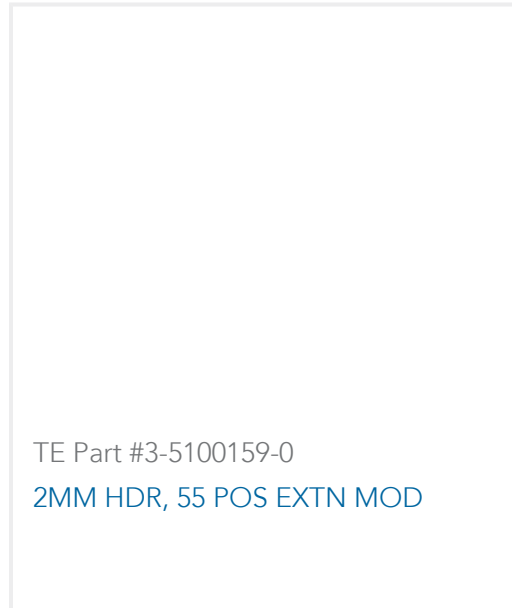

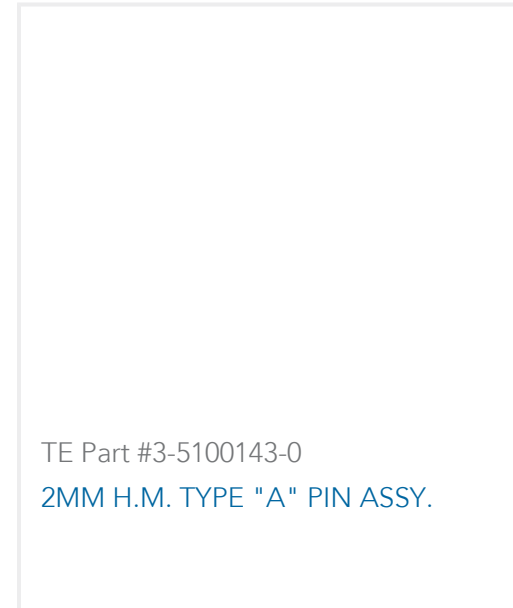
