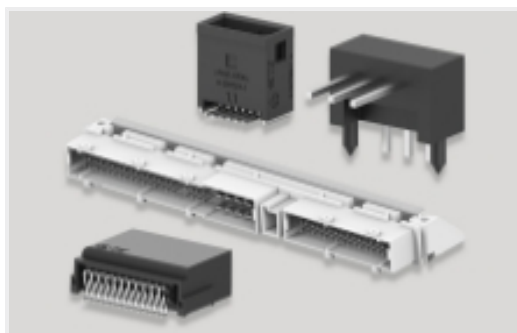

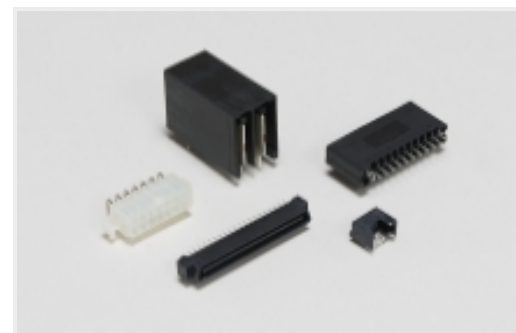

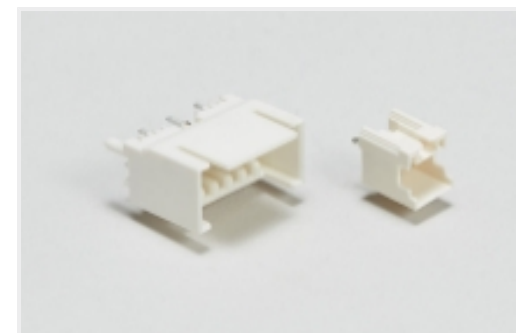
PCB Headers & Receptacles(91)
